67 Dear Member of Parliament ,
68

69 I am writing to you in order to express scientifically founded concerns
70 about effectiveness of Science and Innovation funding by the EU. As I
71 can see from my point of view, the scientific community as a whole is
72 not taking necessary steps to self-assess and streamline the funding
73 requests, through careful considerations of relevance of the different
74 fields to address humanity's challenges in today's world.
75

76 This time is also a time of crisis and emergency, in which spending is
77 necessary to keep the economy and the well being in our societies going,
78 and to ensure that we emerge stronger from this troubled period.
79 However, that spending must also be considered wisely and carefully, as
80 our populations expect and efficiency mandates.
81

82
83 I have developed a website (much of which is in French) which presents:
84

85 – A critical assessment of the way in which the scientific community has
86 acted conservatively, in relation to emergence of new fields, resulting
87 in gaps between the evolutions and the needs of our societies, and the
88 proportions of the different fields of interests within our Universities;
89

90 – An overview of accessible references, many of which are extracts from
91 investigative journalism, presenting the fields which have indeed
92 recently emerged, and seem to me of high interest both for sustainable
93 development, energy transition, and relevant shifts to support jobs
94 throughout European territories.
95

96 – Concerns and recommendations about our digital sovereignty, and
97 targeting the right research activities in Information Sciences to fill

98 our possible gaps, and, in particular, carefully distinguish between
99 development and R&D in the field, in the spirit of the Frascati Manual
100 by the OECD.

104 The web pages are accessible through menus, but I set out below an outline.
105 (The site is secured by the HTTPS protocol, and does not gather any
106 information about the user, be it by cookies or Javascript.)

108
109 The following page purposes to draw a stark distinction between
110 so-called AI and Information Sciences, and advocates careful
111 formalization and specifications for scientific software (in all
112 experimental sciences), for the purpose of validation and
113 reproducibility. Promoting good practices in sciences and software
114 improves both reliability and productivity, and can increase clarity of
115 rational scientific discourse, in the public space, as well as for
116 dependable advice to deciders.

117 The difference between development and R&D in the field, in the spirit
118 of the Frascati Manual by the OECD, is briefly explicated.

147 than the ITER project, have been adequately considered and openly
148 discussed by the scientific community.
